Annual dues are payable on July 1, the first day of the ACEC Florida fiscal year. ACEC dues are billed and collected by ACEC Florida. ACEC Florida and ACEC dues may be paid quarterly.

When your application for membership has been processed and approved by the Membership Committee and the Board of Directors, you will receive a dues statement. This typically takes $2-4$ weeks, so please call if your firm needs the process expedited.
